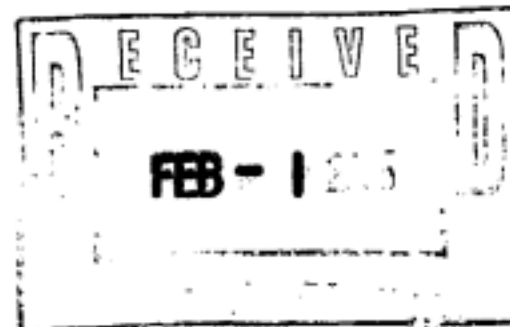

**NOTICE OF PUBLIC COMMENT ON THE SELECTION OF AN INTERIM REMEDY AT THE CITY OF MARTINSVILLE'S WELL FIELD**

The City of Martinsville invites the public to comment on the selection of an interim remedy to protect the City's municipal water supply well field located on the north side of town. The City's well field has been negatively impacted and adversely affected by the industrial solvent perchloroethylene (PCE). The presence of PCE at the City well field has forced the City to evaluate and implement emergency operating procedures at the well field. The City and its residents presently face the threat of injury from ingestion and inhalation of PCE vapors, and the City suffers from an inadequate supply of water for basic services including drinking water and fire fighting. An interim remedy is necessary for the City to continuously provide safe, clean, and adequate water to its citizens. On January 18, 2005, the Board of Public Works ("Board") held a public meeting to, among other things, discuss the need and schedule for designing, installing, and beginning operation of the interim remedy. The Board received two sealed bids in connection with its request for proposal for the proposed design of an interim remedy. On January 21, 2005, the Board held another public meeting to select a design engineer. The proposed interim remedy will likely consist of temporarily installing either an air stripper column or granulated activated carbon drums at the existing well field. Both remedies must be able to remove PCE and related contaminants from the well field to safe drinking levels under peak demand operating conditions. The interim remedy will operate until a permanent solution to the well field contamination is determined and implemented. After reviewing the proposals, the Board awarded the design project to SECOR International Inc. ("SECOR"). SECOR will work with the City to develop the interim remedy. The City requests public comment on the proposed treatment options and any other viable treatment option. The public is encouraged to review SECOR's proposal during the comment period that runs from Monday, January 24, 2005 through Wednesday, February 23, 2005.
