Swift Adhesives has met VRP cleanup objectives and is

awaiting the Certificate of Completion and Covenant not to Sue.

SUMMARY OF ACTIONS:

Swift Adhesives application to the Voluntary Remediation Program was approved on July 23, 1996. The site entered the program for a soil cleanup only. Preliminary site information indicated low levels of VOCs, SVOCs, and PCBs. Confirmatory sampling results detected Polynuclear Aromatic Hydrocarbons (PAH) above tier II criteria in surface soil in a confined area. A limited soil removal was conducted and a tier III risk assessment completed for a single PAH in surface soil. An Environmental Notice will be filed to limit future land use to nonresidential uses, and to require that the PAH contaminated area remain

capped.

NEXT STEPS:

Issue the Certificate of Completion and Covenant not to Sue.

- (3a) Tier II nonresidential cleanup objectives were achieved for the polynculear aromatic hydrocarbons listed below for surface and subsurface soils (except as noted in 3b below) in the area of the site designated on the attached site map (figure 3) as "Area of Concern".

Cleanup criteria for contaminants noted with an asterisk above have not been established by the Voluntary Remediation Program (VRP). Contaminant concentrations at the site were compared to other established risk-based concentrations and it was determined that they did not present an unacceptable risk.

- (3b) Tier III cleanup objectives were achieved for benzo(a) pyrene in surface soil in the area of the site designated on the attached site map (figure 3) as "Approximate Extent of PNA Contamination".
- (4) Tier II nonresidential cleanup objectives were achieved for acetone and cyanide for surface and subsurface soils in the area of the site designated on the attached site map (figure 4).

Land use restrictions:

- Future land use for the site shall remain nonresidential.
- Construction or excavation in the asphalt capped area of the site designated on the site
 map as "Approximate Extent of PNA Contamination" shall not occur without expressed
 prior approval from the VRP.
