IWM Consulting Group, LLC (IWM Consulting) submitted a Comfort Letter Request and accompanying IBP Comfort Letter Request Checklist to the Indiana Brownfields Program (IBP) under separate cover on behalf of the YMCA of Greater Fort Wayne (YMCA). A current Phase I Environmental Site Assessment (ESA) was completed for the Site by IWM Consulting in July 2020. The ESA was prepared for the YMCA in July 2020 and is not available on the Indiana Department of Environmental Management (IDEM) Virtual File Cabinet (VFC).
