This letter is to inform you that the Commissioner of the Indiana Department of Environmental Management (IDEM) has approved the dismissal of the Notice of Violation (NOV), Case No. 2021-28038-D, issued to Restoration International Christian Center, Inc. on August 24, 2022.


Based on information obtained via email with attached verifying documentation on August 19, 2022, between IDEM's representative René J. Repar, and Citizens Energy Group, IDEM was made aware that Restoration International Christian Center, Inc. was connected to Citizen's utility services. Due to the connection to the utility, IDEM has inactivated the facility as a public water system and determined that no violations exist this time. Therefore, the issues addressed by the NOV are now considered by IDEM to be resolved and the action is hereby dismissed.
