Dear Mr. Kaur:

On Jan 24th, 2024, the Emergency Response Section within the Office of Land Quality received notification that a spill occurred at SR 26 and I-69 near Gas City, Grant Co Indiana. This notification was provided by the Grant County Emergency Management Agency indicating that a release of fuel had taken place at that location where fuel was still present. IDEM OSC Cage determined that the accident occurred on Jan 13, 2024. The responsibility for reporting, containing, and conducting a spill response is outlined in 327 Indiana Administrative Code (IAC) 2-6.1-7(3).

On January 29, 202, On-Scene Coordinator, David Cage of the Emergency Response Section responded to a spill at the above referenced location. Staff observed the following violations:

327 IAC 2-6.1-7(2), requires activities to be performed, or direct others to perform activities, to accomplish a spill response. Diesel fuel (Free Product) was observed during the Feb 29th site visit (16 days after the incident) The spill response was not adequately performed.

327 IAC 2-6.1-7(3), requires a spill report be communicated to the IDEM's 24-Hour Emergency Spill Line within 2 hours of discovery. The spill occurred on 1/13/24 and notification was not received until 1/24/24, which is not within the 2 hour reporting requirement.





A written detailed explanation documenting compliance with each of the requirements listed above needs to be submitted. Pursuant to 327 IAC 2-6.1-7 (4), the IDEM is requesting an explanation documenting compliance and a written copy of the spill report be submitted to IDEM, Office of Land Quality, Emergency Response Section, 2525 North Shadeland Ave., Suite 100, Indianapolis, Indiana 46219-1787. Per 327 IAC 2-6.1-4 (17), please submit the following information:

- Name, address, telephone number, and E-mail address of the person making the spill report.
- Name of the Responsible Party (RP), contact name, address, telephone number and E-mail address.
- Location of spill.
- Time of the spill.
- Identification of the substance spilled.
- Approximate quantity of the substance that has been or may further be spilled.
- Duration of the spill.
- Source of the spill.
- Identity of any response organization responding to the spill.
- What measures have been or will be undertaken to perform a spill response.
- Any other information that may be significant to the response action.
- Map
- Photos
- Confirmatory Sampling
- Disposal Documentation

Failure to adequately respond to this violation letter may result in a referral to IDEM's Land Enforcement Section. If you have any questions concerning this matter, please contact OSC David Cage at (317) 691-6433.
