RE: Town of Claypool Compliance Plan Q2 2024 Update NPDES Permit No. IN0039870 Case No. 2021-28427-W

Dear Ms. Aletha Lenahan:

The Town of Claypool has entered into an Agreed Order (Case No. 2021-28427-W) to address effluent limitation violations, assure proper sludge/solids handling, implement a maintenance program, and locate and eliminate sources of inflow and infiltration (I/I). The Town of Claypool developed a Compliance Plan to conduct Collection System Rehabilitation, Wastewater Treatment Plant (WWTP) and Lift Station Improvements, WWTP Lagoon Cleaning, and Storm Sewer Improvements. The Compliance Plan (CP) was approved by the Indiana Department of Environmental Management (IDEM) on June 20, 2023.

Actions Implemented:

Since the most recent quarterly Compliance Plan update, the Town of Claypool has:

- Continued the design of wastewater utility improvements to approximately 50% completion as described above and included in the attached CP.
- Continued coordination with the Indiana Finance Authority (IFA) State Revolving Loan (SRF) program to obtain an agreeable financing package. The Town's application ranked 33rd out of over 100 applications, which is outside of the fundable range. SRF has urged the Town to evaluate regionalization options to improve the score, improve financial package terms, and potentially minimize rate impacts.

Summary of Planned Actions:

The following activities are scheduled to be completed throughout 2024 or as part of the ongoing Compliance Plan:

- Continue project financing coordination with the IFA SRF.
- Continue to solicit alternative funding options.
- Continue design activities of the proposed project.
- Obtain all required permits by October 31, 2024, which was modified from June 30, 2024.
 The IDEM OWQ WWTP Construction Permit application will be submitted to Facilities Construction & Engineering Support Section as soon as possible after the Preliminary Effluent Limitations (PELs) are obtained from the Municipal Permits Section.
- Proceed with bidding and construction activities once all permits are obtained and project financing is in place.

Please see the attached revised Compliance Plan reflective of the current wastewater utility improvements implementation schedule.
