
A representative of the Indiana Department of Environmental Management (IDEM), Office of Air Quality (OAQ), has reviewed the FY2023 Annual Notification concerning Rinker Materials Hydro Conduit Division located at 6662 West County Road 350 North in Greenfield, Indiana. Pursuant to permit number S059-18216-00034, Condition B.1 and 326 IAC 2-9, the FY2023 Annual Notification was required to be submitted no later than January 30, 2024. The FY2023 Annual Notification was submitted on February 29, 2024, in violation of permit number S059-18216-00034, Condition B.1 and 326 IAC 2-9. Additionally, IDEM does not have a record of the FY2022 Annual Notification having been submitted.

This violation occurred in FY2024 and should be included in the FY2024 Annual Notification, which is required to be submitted no later than January 30, 2025.

This matter will be referred for formal enforcement action. IDEM Office of Air Quality would like to take this opportunity to encourage discussions concerning the facts of the case, any additional information that may be available, and to provide you with information concerning the enforcement process.
