This letter is to confirm the receipt of your permit renewal application for Marketing and Distribution Permit No. IN LA000782. The existing permit was issued on January 7, 2015, and scheduled to expire on December 31, 2024. According to 327 IAC 6.1-3-1(c), applications for permit renewal are required to be submitted at least 180 days prior to permit expiration. By meeting this deadline, an existing permit is administratively extended until such time that a decision is made on the requested renewal. Based on the expiration date of your permit, your renewal application was due to be submitted on or before July 4, 2024. As your application was received on July 1, 2024, your current permit remains valid until a decision is made on your renewal application.
