Speedway LLC (Speedway) is providing this correspondence to the Indiana Department of Environmental Management as a commitment to assure future compliance to the conditions of the National Pollutant Discharge Elimination System Permit for the above-referenced site. Continued maintenance and equipment upgrades are ongoing with the operating wastewater treatment plant. Additionally, Speedway is in the initial stages of completing site redevelopment. Pre-planning meetings have been initiated and due diligence/permitting is underway. The redevelopment of the site would include new site grading/drainage and a connection to the municipal sewer system once extended to the site.
