Please address the following comments developed from an engineering review of your waste tire operation registration dated June 18, 2024 (VFC#[83655629](#)).

1. In accordance with IC 13-20-13 and 329 IAC 15-3-3, please provide a legible topographic map or equivalent that shows the boundaries of the operation. The three (3) maps provided on one (1) 11 x 17-inch paper are too small to interpret and expanding them only makes them less discernable. Providing each of these maps as individual 8-1/2 x 11 inch is recommended.
2. Please provide a legal description or certified copy of the deed of the property to be used. The survey map should be certified by a licensed engineer or surveyor.
3. The Site Plan should additionally depict the following:
  - a. Location, length, width, and height of each waste tire storage area.
  - b. Separation distances between tire piles.
  - c. Separation distances between tire piles and other salvaged equipment, lot lines, buildings, combustible materials, and other on-site activities.

The above can be shown on the submitted drawing or on a separate drawing, and additionally described in a narrative.

**Please note:** If waste tire storage or waste tire processing is located within the area of the W Transfer Station (SW ID 54-008) facility boundary, then a modification to the W Transfer Station's solid waste processing permit is required.

4. 329 IAC 15-3-17(e) requires that the owner or operator of the waste tire storage site or waste tire processing operation shall maintain the following at the storage site or processing operation:
  - a. A first aid kit
  - b. Fire extinguishing equipment that:
    - i. complies with the Indiana Fire Code at 675 IAC 22
    - ii. is accessible at the storage site or processing operation
    - iii. is in the immediate vicinity of processing operations while processing waste tires.

Please confirm these will be maintained (this can be included in the contingency plan).

5. Please submit a copy of the Registration Fee Transmittal Form (State Form 47215) and Payment you sent to the address given on the fee transmittal form.
6. Pages 3 and 4 are missing from the submitted Contingency Plan (State Form 54817). Submit the missing pages with complete information.
7. Please note: In accordance with 329 IAC 15-2-13.4, if you store more than 1,000 waste tires outdoors or 2,000 waste tires indoors, then an Application for Waste Tire Storage Site Registration State Form 47222 (R5 /12-17) and registration fee needs to be additionally submitted.
