Section VI Reporting Requirements

Paragraph 15.a. - DGBV Planned Openings

Not applicable during this reporting period. This obligation has been completed.

Paragraph 15.b - DGBV Planned Openings

Paragraph 15.c - DGBV Planned Openings

Since there were no exceedances of the 40% six-Minute Average Opacity Standard during the 26-week period identified as part of Paragraph 15.a, this section is not applicable.

Paragraph 15.d - Blast Furnace Casthouse

Not applicable during this reporting period. This obligation has been completed.

Paragraph 15.e - Coke Oven Battery SOPs

Not applicable during this reporting period. This obligation has been completed.

Paragraph 15.f - Beaching

Cleveland-Cliffs Burns Harbor timely submitted an application to IDEM on April 7, 2021 to satisfy Paragraph 15.f(4) that states, "No later than 12 months following completion of the monitoring required in Paragraph 15.f.(2), ArcelorMittal Burns Harbor shall submit an application to IDEM to modify its federally-enforceable non-Title V Permit such that ArcelorMittal Burns Harbor is required to operate as specified in Paragraph 15.f.(1) to ensure compliance with applicable visible emission limits." This application submittal was timely since paragraph 15.f.(2) monitoring was completed on April 8, 2020. The permit modification incorporating the requirements of 15.f(1) was issued by IDEM on August 2, 2021. The obligations of 15.f(2), (3) and (4) have been completed.

Paragraph 15.g. - Electronic Data Management Program

Cleveland-Cliffs Burns Harbor has commenced the implementation of an electronic data management program for all calibrations and inspections required by the Title V Permit T127-31788-0001, as previously reported. This obligation has been completed.
