Please note that the service connection information will be used to verify completeness of your lead service line inventory (which must be submitted to IDEM by October 16, 2024), and to accurately establish your system's annual drinking water fees. **If we do not receive any updates from you, we will assume the information is valid for both the number of service lines that will be in your submitted inventory and determining the drinking water fees.** If you have questions about the annual fee, please contact Ms. Carol Guidry at 317/232-8472.

Commissioner**RE: DOES IDEM HAVE YOUR CYBERSECURITY CONTACT?**

In 2016, the Governor created the Indiana Executive Council on Cybersecurity in response to the ever growing risks facing the State's public and private sectors associated with online threats. A primary focus of the council has been to ensure Indiana's water and wastewater sectors have access to robust and resilient cyber protections. Additionally, new state and federal regulations now require water and wastewater utilities to develop and maintain cyber security plans and comprehensive risk assessments. In an effort to assist utilities with these undertakings, a subcommittee devoted to Indiana's Water & Wastewater Cybersecurity was formed and tasked with developing tools and training materials for use by water and wastewater utilities to make them more cyber resilient. The first and foremost challenge in this effort has been getting in touch with the right people at each utility. Each and every utility can and should benefit from the resources that will be made available by providing a point of contact the committee can use to relay guidance, training materials and information. IDEM is assisting in this effort by adding a cyber/SCADA person to its existing utility contacts database. It may be an operator or employee of the utility, a computer technology employee of a city or county that also works with local utilities, or even a third party vendor who provides computer support.

Even if your utility does not have SCADA controls of operations you should provide a contact so you can receive notices, training materials, and guidance from the committee. With many small utilities, computerized billing, data storage, and email communications are vulnerable to cyber risks even if the plant operations are not directly connected to the internet.

As of this date, IDEM has a listed contact for all systems with populations at and above 3300. If you are a system below 3300 and have not yet provided us with a contact name, please do so with this update. Likewise, if you are a system of any size who we have a cybersecurity contact for but you now have a different person in place, please provide us that information so that we may update your records.

Please provide a name, address, email, and a phone number if possible. If you have questions about how cybersecurity applies to your system, or have questions in general about who might be the best individual to designate, please contact Travis Goodwin at Tgoodwin1@idem.IN.gov, or call him at (317) 234-7426.

Your help in providing a utility contact to IDEM is greatly appreciated. With your help, we can ensure Indiana's water and wastewater utilities are secure and able to provide their valuable service to the people of Indiana for years to come.
