Subject: WATER MAIN BREAK @ 2601 VALE PARK RD

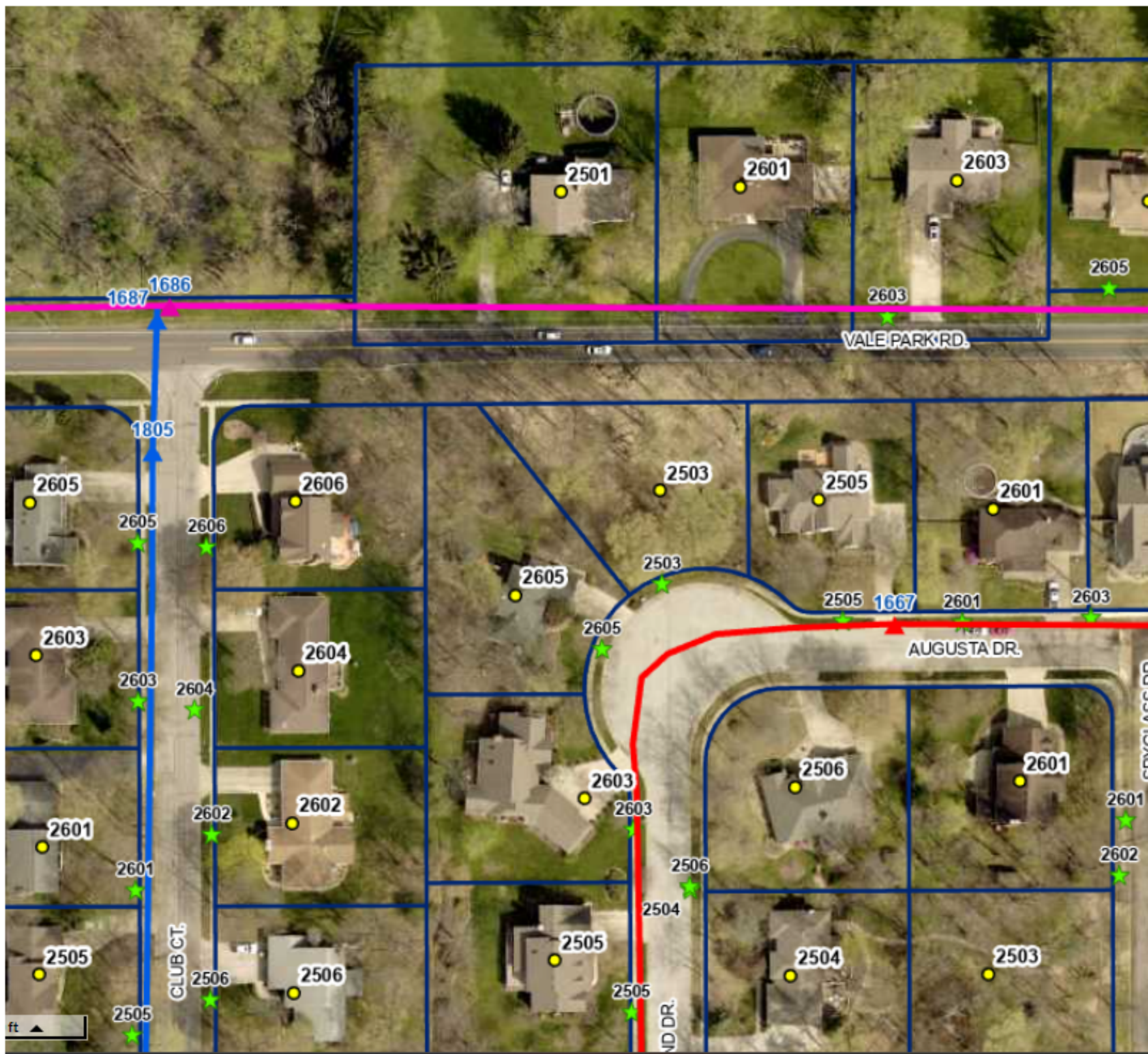
Good Morning,
