To All Parties:

The Indiana Department of Environmental Management (IDEM) received a notification for the facility referenced above on 8/15/2024. The form can be found on the IDEM Virtual File Cabinet (VFC) at <http://vfc.idem.in.gov> under VFC #83682997.

IDEM staff reviewed the information contained in this form and additional information is required. The following items need to be addressed:

1. 0901 - UST Attributes - Current/previous submissions indicate a UST(s) was Part of a Compartmented UST.
- Historic records support 5K USTs are compartmented

2. 1803 - Other - Other tank/compartiment deficiency
- Historic records support compartmented tank is fiberglass

Please resubmit the necessary pages of the notification form and/or backup resolving the deficiencies identified within fourteen (14) days of receipt of this letter.

Failure to submit the required information detailed in this deficiency letter is a violation of Indiana Code (IC) 13-23-14-2 and the Indiana Administrative code (IAC) 329 IAC 9-2-2 and 40 CFR 280.34. Please note, IDEM has incorporated the majority of the federal underground storage tank regulations of 40 Code Fed. Reg. (CFR) Part 280 via 329 Ind. Admin. Code (IAC) 9-1-1. All CFR citations refer to the regulation as incorporated. Additionally, the submittal of false information on UST Notification Forms, as well as the failure to submit required UST Notification Forms, is subject to a \$10,000 penalty.
