On behalf of the Wayne County Highway Department (WCHD), August Mack Environmental, Inc. (August Mack) is submitting this document to provide additional information regarding the in-place closure of one (1) 1,000-gallon diesel Underground Storage Tank (UST) at the WCHD facility located at 8198 US 40 West in Centerville, Indiana (Site). The original *UST Closure Report* was submitted to the Indiana Department of Environmental Management on September 24, 2024.

August Mack mobilized to the Site on August 15, 2024, to provide oversight and UST closure sampling activities related to the removal of one (1) 12,000-gallon diesel UST and one (1) 12,000-gallon gasoline UST. In addition to the two (2) 12,000-gallon USTs, one (1) 1,000-gallon diesel UST, which provided fuel to the on-Site emergency generator, was to be closed in-place. Due to a scheduling conflict, the contractor (Allied-Ott Petroleum Equipment, Inc, (AOPE)), had to mobilize to the Site at a later date to perform the in-place closure activities.

AOPE mobilized to the Site on October 23, 2024, to perform the in-place closure activities. The in-place closure consisted of removing the remaining fuel within the UST via vacuum extraction. The fuel was transferred to a temporary Aboveground Storage Tank (AST) and will be reused upon installation of a new AST system to be installed to provide fuel to the back up generator. Following removal of the fuel, the concrete pad overlying the UST, as well as the overburden material was removed and stockpiled on-Site for reuse as backfill material. The UST was filled with six (6) cubic yards (cy) of flowable fill and the overburden and concrete pad material were placed on top of the UST.
