Dear Sir or Madam,

We are respectfully notifying this taxing authority of a change that will occur regarding Giant Eagle, Inc. ("GEI"), FEIN 25-0698270, that may impact the Company's current licenses in your jurisdiction. These changes are outlined below and will become effective on or by July 25, 2024.

GEI is a large privately owned supermarket and convenience store retailer operating stores in Indiana, Maryland, Ohio, Pennsylvania, and West Virginia. GEI holds interests in both supermarket and convenience store businesses including GetGo Operating, LLC ("GetGo"), FEIN 83-1723332.

GEI is bifurcating its supermarket and convenience store operations to better align with business operations. On June 29, 2024, GEI contributed GetGo through a series of sequential transfers to the capital of Riser Foods Company ("RFC"), FEIN 52-2067965. On or by July 25, 2024, GEI will then transfer convenience store assets to GetGo. Therefore, on or by July 25, 2024, the convenience store operations, assets, and the related licenses will be owned by GetGo. Please see Exhibits A and B for the before and after structures.

It is our intention that this letter serves as the proper notification for the transaction outlined above and will result in changes to the information on the existing GEI licenses. All current business operations at the local store level will continue unchanged and the ultimate ownership of the Giant Eagle family of companies will remain unchanged.

Pursuant to the information outlined above, we respectfully request that the current and future licenses and accounts for GEI to be updated accordingly, effective on or by July 25, 2024 to GetGo.

Additionally, we are working with our tax advisors at Ernst & Young, LLP ("EY") on this transaction. An EY representative will be reaching out directly to discuss this change and work with your team to get any needed updates to the licenses in place.

We sincerely appreciate your consideration in this matter and look forward to working with you to ensure a smooth update of our licenses.
