On October 10, 2023, representatives of the Indiana Department of Environmental Management (IDEM), Office of Water Quality, conducted an inspection of Indiana Invaders Soccer Complex, located in South Bend, in St. Joseph County, Indiana. This inspection was conducted pursuant to IC 13-14-2-2.

IDEM issued an Inspection Summary Letter on October 11, 2023, stating that significant deficiencies existed. You were given 30 days to provide IDEM with a written response which detailed measures to correct the deficiencies. Then, on December 31, 2024, a Final Notice of Noncompliance was issued. To date, you have not responded to the significant deficiencies cited in the October 11th Inspection Summary Letter and are in violation of 327 IAC 8-2.3-6(a)(2) or you have not submitted corrective measures.

Within 15 days of receipt of this letter, you must provide a written detailed explanation, documenting corrective measures for each of the significant deficiencies cited in the October 11th Inspection Summary Letter. 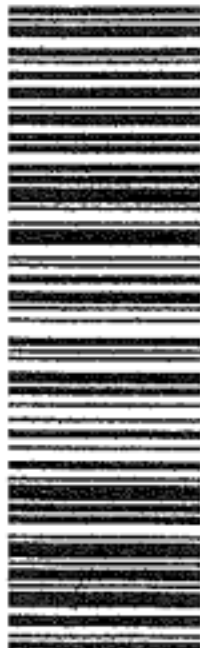
