This will acknowledge receipt of the copy of the deed recording which was required in accordance with Indiana Code 330 IAC 4-9-5 and letters sent to you on June 22, and October 9, 1987. Also, leachate which had been surfacing in the northeast corner of the site has been sealed off and additional final cover has been applied, graded, and seeded. These items were verified and a final inspection conducted by Mr. Timothy Hotz on June 29, 1988.

Please recall that you, as owner of this former landfill, shall always be responsible for maintaining the final cover and any necessary controls over gas or leachate produced.
