Re: Request for Stack Test Extension

Dear Mr. Johnson:

INTAT Precision, Inc. (INTAT) is submitting this request for an extension to complete the required stack testing at our facility in Rushville, Indiana. Conditions D.2.10(a), D.2.10(b), and D.2.10(c) of our Title V Operating Permit No. T139-40852-00011 require testing to be completed on the below identified equipment in Plant 1 Line 2 not later than five (5) years from the date of the most recent valid compliance demonstration.

The table below outlines the processes/controls and their required test dates:



INTAT submitted stack test protocols on December 9, 2019 to perform all of the Plant 1 Line 2 testing for the week of March 22, 2020. Due to circumstances outside of the facility's control, INTAT will be unable to perform the required testing ahead of the April 2020 deadlines.

Given the current situation with the COVID-19 pandemic, we request an extension to complete the stack testing on the Plant 2, Line 1 equipment that have testing timeframes due in April 2020. While we believe that testing could be completed as early as the week of May 18, 2020, we are requesting that the deadline to complete the stack testing on these processes be postponed for 180-days until October 19, 2020. We propose to resubmit the testing protocols 35-days prior to the intended test date once those dates have been confirmed with our stack testing consultant.

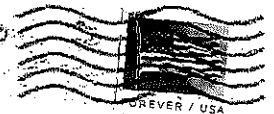
