Jeff,

Thank you, we are all doing ok so far.

As far as any formal extension on the construction permit application due date: since that compliance schedule to meet phosphorus is set in the permit, a formal extension cannot be granted. But we understand your concern and will use discretion as far as any further action in light of potential impacts from COVID-19, giving you additional time. But we do expect the Town to make their best effort to comply. I have noted in my file, regarding your schedule, that you may be delayed in getting the application in to IDEM. Please do send me a progress report by the next scheduled date of 6/1/20 to let me know how you are progressing with the application.

Also, as an FYI, the State has recently released an IDEM Policy Document (found in the link below) regarding noncompliance and discretion when evaluating any issues.
