Greetings Mr. Dunovic,

As mentioned on our phone call, the 5-year NSPS Kb primary seal inspection is coming due in April for tank 1610 located at our Hartsdale Terminal in Lake County. Due to the ongoing Covid-19 restrictions within Enbridge, the State of Indiana, and guidance from the Federal government, it has been a challenge to assemble our inspection team to perform this inspection in a timely manner. I also imagine that it would be difficult to have an IDEM observer present during this inspection. In light of these challenges, Enbridge requests the 5-year inspection be delayed until September 2020. This would allow enough time to pass for things to calm down with the virus, as well as align this tank with the inspection schedule of the other nine tanks located at this terminal. This is the first primary seal inspection since the tank was constructed back in 2015 and the secondary seal is inspected annually. We appreciate your consideration in these unprecedented times. Thank you!
