Heritage Environmental Services, LLC (“Heritage”) submitted a Class 2 Permit Modification to the Indiana Department of Environmental Management (“IDEM”) in a letter dated May 3, 2020. Such submissions require a public notice as specified at 40 CFR 270.42 (b)(2) and a public meeting within the 60-day public comment period as required by §270.42 (b)(4).

Heritage intends to have the public notice published in the Greencastle Banner Graphic and will also mail the notice to the facility mailing list. The notice normally includes the details of the public meeting required at §270.42 (b)(4), such as date, time, and location. However, at the time of the notice, Indiana will still be partially under the Stay-At-Home Order that is critical to reducing the spread of COVID-19. Executive Order 20-26 includes restrictions that would possibly limit unrestricted participation by all interested parties in an in-person public meeting. As such, Heritage is potentially unable to hold a traditional public meeting within the time frame prescribed by §270.42 (b)(4) and is requesting the approval of a plan to hold an online meeting on a web-based platform to fulfill the requirement of §270.42 (b)(4). Heritage is also requesting to be allowed to publish the public notice within 10-days of the submittal date, rather than the stipulated 7-days at §270.42 (b)(2). The extension is needed to finalize the details of the online meeting in order to obtain and provide a web address in the notice to be published. Heritage is making this request in compliance with Executive Order 20-5.

The following actions are being taken to ensure the public has the opportunity to receive information and participate as intended by the requirements:

1. Heritage will provide reference and link to submitted permit modification request and documents in the IDEM’s Virtual File Cabinet (“VFC”) in the public notice. The link is also being placed online at www.heritage-enviro.com.

2. Heritage is providing reference and link to an online platform hosting the public meeting. The current scheduled time and date is 2:00 P.M. on June 17, 2020. The platform is BlueJeans. The meeting link will also be placed online at www.heritage-enviro.com.
3. If the Stay-At-Home-Order has ended and the restriction on public gatherings has been amended to allow a gathering by the scheduled online meeting date, Heritage will provide a venue for in person attendance as well as the ability attend online at the time and date that was published in the public notice. The details of the venue will be posted online at www.heritage-enviro.com.

Heritage Environmental Services, LLC ("Heritage"), located at 7901 W Morris Street, Indianapolis, Marion County, Indiana owns and operates a fully permitted hazardous waste facility. The facility is physically located at 4370 West County Road 1275 North, north of state highway 236. Heritage is hereby giving notice of a Class 2 modification request submitted to the Indiana Department of Environmental Management ("IDEM") for modification of the facility's Resource Conservation and Recovery Act ("RCRA") permit.

Permit modifications are prepared to reflect or request changes in the facility operations relevant to the issued permits. Heritage has submitted a Class 2 permit modification to the IDEM to revise the waste analysis plan. The application and documents submitted to IDEM are available online in the IDEM Virtual File Cabinet ("VFC") as VFC document number ["insert"]. The sixty-day public comment period begins May 10, 2020 and ends on July 9, 2020.
