**GENERAL INFORMATION** 

#### **Comments:**

On Tuesday, June 18, 2024, Solid Waste Compliance Inspector Chad Pittman, conducted an open dump complaint follow-up inspection on Jefferson County property parcel 39-15-13-000-025.001-011 located at 2743 North 1100 West, Lexington, Indiana 47138 (IDEM Incident 110146).

The open dump complaint follow-up inspection was conducted pursuant to IC 13-14-2-2. In accordance with IC 13-14-5, a summary of the inspection is provided below.

The inspector arrived at 2743 North 1100 West, Lexington, Indiana at 3:00 PM on Tuesday, June 18, 2024. The inspector requested and was granted permission to conduct a follow-up inspection on the property by Leah Hilty.

The inspector found that Mr. Hilty has land applied the manure pile to his hay field. At the conclusion of the follow-up inspection, the solid waste compliance inspector did not observe any regulated solid waste violations on Jefferson County property parcel 39-15-13-000-025.001-011 located at 2743 North 1100 West, Lexington, Indiana.

The property is in compliance with rule 329 IAC 10-4-2, which states: "No person shall cause or allow the storage, containment, processing, or disposal of solid waste in a manner which creates a threat to human health or the environment, including the creating of a fire hazard, vector attraction, air or water pollution, or other contamination."

The property is also in compliance with IC 13-30-2-1, which states: "A person may not discharge, emit, cause, allow, or threaten to discharge, emit, cause, or allow any contaminant or waste, including any noxious odor, either alone or in combination with contaminants from other sources, into the environment.

With no evidence of solid waste violations at the time of the inspection, no further action is necessary and the Solid Waste portion of IDEM Incident 110146 Hilty OD will be closed.
