The Indiana Department of Environmental Management (IDEM) received the Bartholomew County LF II, "Construction Certification Report-2023 Partial Closure" (CCR) on April 18, 2024 (VFC #[83638087](#)) for partial closure of 4.25+/- acres of final cover. IDEM has determined partial closure requirements at 329 IAC 10-22-3 (a) and (b) are satisfied:

- a. The CCR was determined adequate on May 6, 2024 (VFC #[83634759](#)).
- b. A certification, signed by both the owner and engineer, was received by IDEM with the CCR on April 18, 2024 (VFC #[83638087](#)).
