Dear John Haney:

A representative of the Indiana Department of Environmental Management (IDEM), Office of Air Quality (OAQ), has reviewed the Annual Compliance Certification (ACC) for calendar year 2023 submitted by The Ford Meter Box Company, Inc. located at 774 Manchester Avenue in Wabash, Indiana. As a result of information obtained during that review, IDEM alleges violations of Permit T169-45505-00003 have occurred.

Our records indicate that no prior violation letter has been issued regarding the following deviations reported in your ACC:

- 1) Stack testing for PM, PM10, PM2.5, and lead on unit CLS-05 was required to be conducted by March 4, 2023, but was not conducted until August 4, 2023, in violation of Permit condition D.1.5(d).
- 2) Stack testing for PM, PM10, PM2.5, and lead on unit BH-G was required to be conducted by July 11, 2023, but was not conducted until August 11, 2023, in violation of Permit condition D.1.5(b).

This matter will be referred for formal enforcement action. IDEM Office of Air Quality would like to take this opportunity to encourage discussions concerning the facts of the case, any additional information that may be available, and to provide you with information concerning the enforcement process.

An enforcement case manager will contact you to discuss this matter and schedule an informational meeting concerning this matter. In the meantime, please
