As I mentioned on our call, we received the attached financial assurance reinstatement. \$10,000 is the required amount for waste tire transporters, however, a record review shows the last registration on file for Larry's Tire expired in 2006 (Virtual File Cabinet Document 63783172). If you think this is a mistake or another name is being used for your company, please let me know. Waste tire transporters are required to submit a renewal application every 5 years.

## Required Items:

- Fee Transmittal State Form 47215 (attached) \$25 new application fee, send the payment to the PO Box or as directed on the form, include a copy with the rest of the application. **Do not** send the full application to the PO Box.
- Application Form 47220 (attached) and supporting documents
  - Email the completed application and <u>copy</u> of the payment as a PDF to <u>SolidWasteSubmittals@idem.in.gov</u>. You can copy me. There is no need for a hard copy of the full application if you email it.
  - Section 3, Full name: Should be the company's name. All businesses doing business in Indiana should be registered with the Indiana Secretary of State.

  - Once we receive the application, the financial assurance may need to be updated to reflect our current language and show your assigned registration number.
