Dear Mr. Perry:

TransMontaigne Operating Company, L.P. (TransMontaigne) owns and operates the Evansville Terminal and the terminal is authorized under Permit F163-41070-00063. Tank #9 is identified as an internal floating roof storage tank and is subject to NESHAP Subpart BBBB while storing gasoline.

Tank 9 is a gasoline storage tank, and as such, per §63.11092(e)(1) a storage tank subject to the Standard shall perform inspections of the floating roof system according to the requirements of §60.113b(a) and is subject to the 10-year inspection requirements of §60.113b(a)(4). TransMontaigne is electing to switch the methodology to demonstrate compliance to 40 CFR 63 Subpart WW, as allowed by §63.11092(e)(1), 40 CFR 63.1063(c)(1) and 40 CFR 63.1063(d)(1). As such, we are providing this 30-day notification that we will be performing an in-service inspection for Tank 9. This inspection will take place no sooner than July 21, 2024.

If the Indiana Department of Environmental Management wishes to be present to observe this inspection, please contact me and I will coordinate with you and the terminal on the actual inspection date.
