Re: Combined Sewer Overflow Program **Audit Summary** Logansport Utilities State Judicial Agreement No. 09C01-0709-CC-00077 NPDES Permit No. IN0023604 Cass County

On March 6, 2024, staff from the Indiana Department of Environmental Management (IDEM) Office of Water Quality (OWQ) conducted an audit of both the approved Combined Sewer Overflow (CSO) Long Term Control Plan (LTCP) and approved CSO Operational Plan (CSOOP) implementation in Logansport. Our appreciation goes out to you, Jackson Wiseley, Cameron Dillon, and Omar Gonzalez for participating in the CSO audit.

The Logansport LTCP was approved in August 2010. The approved LTCP includes a 17-year schedule to implement projects designed to result in no more than 4 untreated CSO events in a typical year. The audit indicated that Logansport is in compliance with implementing the approved LTCP schedule.

The following observation was made during the audit:

Logansport is currently implementing the CSO 011/012 Linden Avenue Project. This project is scheduled for completion in November 2024. Logansport understands that IDEM requires notification upon completion of all LTCP projects.

Logansport has an approved CSOOP. The audit indicated that Logansport is in compliance with implementing the approved plan. Logansport's implementation of each of the minimum controls in Attachment A of NPDES Permit No. IN0023604 shall be documented in its approved CSO Operational Plan (CSOOP). Logansport shall update the CSOOP, as necessary, to reflect changes in its operation or maintenance practices; changes to measures taken to implement the above minimum requirements; and



changes to the treatment plant or collection system, including changes in collection system flow characteristics, collection system or WWTP capacity or discharge characteristics (including volume, duration, frequency and pollutant concentration). All updates to the CSOOP must be submitted to IDEM, Office of Water Quality, Municipal NPDES Permits Section.

The following observations were made during the audit:

- Logansport submitted a CSOOP update to IDEM in September 2023. The update is currently under review.
- IDEM recommended that Logansport develop SOPs for operating and maintaining all wet weather storage facilities.
- Logansport discussed the possibility of physically closing CSO 015 in the future.
 Logansport may submit photographic documentation of how the flow to outfall 015 has been eliminated, along with a request to remove outfall 015 from NPDES permit No. IN0023604, and IDEM will process a modification of the permit.
- During the audit Logansport showed IDEM various wet weather regulator structures to clarify how wet weather flow gets from the regulator into the CSO outfall pipe. IDEM observed, at certain locations, a wet well in the manhole containing the influent portion of the CSO outfall pipe. IDEM observed standing water in these wet wells. Although significant solids were not observed, IDEM cautioned Logansport to be mindful of solid buildup in these structures, and recommended, if necessary, development of an SOP for cleaning these wet wells between CSO events.
