**Alert Plan:** Notify all plant personnel. Evaluate procedures to reduce emissions of air pollutant identified by IDEM. Operate the plant at the minimum mix temperatures needed.

**Warning Plan:** Eliminate all unnecessary emission processes. Check the operation of all dust abatement equipment to ensure maximum performance. Water roadways.

**Emergency Plan:** Limit plant production to only vital and necessary jobs. Treat the stockpile area and work yard area with water.

**Estimated Reduction Amounts:**

Alert Plan	10%
Warning Plan	40%
Emergency Plan	75%

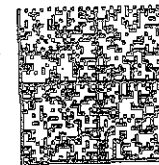
