Hello Bruce and Kevin,

IDEM has reviewed the *Progress Report* – 3^{RD} *Quarter 2023* (Q3 Progress Report) and requests the following comments be incorporated in RWP implementation.

- 1. Soil gas (SGe) sampling along the east property boundary has been approved as an alternative method of evaluation of vapor intrusion potential at the 122 South Front Street residence. As a supplemental component to this alternative, the consultant should submit a line of evidence (LOE) indicating the sample results are representative of what would be under the slab. If access to the residence is provided in the future, this LOE will not be necessary.
- 2. Given the historical fluctuations in groundwater flow, samples from downgradient wells, MW-22, MW-26, and MW-26S should be collected in the next sample event and included in the plume behavior evaluation.

If I am not mistaken, the residence adjoining the Site was vacant, is that correct?...I know there was some back and forth in terms of access. If you have any questions, or would like to touch base, feel free to contact me.
