Apart from submitting the application to the local library I don't think you have to update any

other forms. And to answer your question about the timeframe of the permit modification: Normally it takes 120 days for a FESOP SPR, and the days are counted right after the IDEM OAQ had received your application. And , about the PTE calculations it is a normal procedure for us that we always have to count towards the worst-case scenario and for that reason we need to always count 8760 hours per year. Thanks!
