Dear Mr. Dunfee:

Your vegetative matter composting registration has expired since you did not submit a renewal application before your registration's expiration date of September 1, 2023 (VFC #[82612322](#)). An IDEM inspector visited your facility on June 19, 2024 (VFC #[83657577](#)) and confirmed there is no ongoing composting activity. Since you are no longer registered, you must cease all composting operations.

If you wish to compost vegetative matter again in the future, you must submit a new registration application and receive a new approval. The compost application State Form 50414 is enclosed. Please note certain composting activities are exempted by Indiana Code (IC) 13-20-10. More information is available on IDEM's website at <https://www.in.gov/idem/waste/waste-industries/yard-waste-and-composting-facilities/>.

Public records for your facility are available in IDEM's Virtual File Cabinet (VFC) at <https://www.in.gov/idem/legal/public-records/virtual-file-cabinet/>. By searching for the Solid Waste (SW) Program ID 53-06 in the *Quick Search*, you may find previous decisions along with application documents submitted for your former registration.
