Proposed IDEM Application for a Confined Feeding Operation

Proposed location: 6000 East 100 South, Bowling Green, Indiana

Clay County

CFO Farm ID # 7080

The Indiana Department of Environmental Management (IDEM) has organized a teleconference meeting to discuss the above application received on February 5, 2020, from Skyler and Colton Miller to construct a 4,300 head swine confinement facility. This telephone meeting is being set up at the request of local neighbors of the proposed facility. The teleconference meeting setting is due to current restrictions to travel and meetings due to the COVID-19 pandemic.

Confined feeding operations (CFO) are reviewed and either approved or denied under the Confined Feeding Control Law (IC 13-18-10) and the regulations set forth in Indiana Administrative Code for Confined Feeding Operations (327 IAC 19).

The meeting will consist of a short introductory presentation from IDEM staff on the Confined Feeding Program in Indiana and what IDEM does and does not regulate. Participants can ask questions of the IDEM Office of Land Quality permitting and compliance staff IDEM staff available at the meeting: Joe Williams, CFO Permit Section Chief; Thomas Park, CFO Permit Manager; Mitchell Halcomb, CFO Permits Senior Environmental Manager; Charles Grady, CFO Compliance Section Chief, Shyamala Raman, Section Chief for the Engineering Section; Leila Trabelsi, Permit Engineer, and Scott Waninger, Geologist with IDEM's Geology Section. Also available during the meeting will be Rebecca Joniskan, OLQ Permits Branch Chief; Corey Webb, OLQ Deputy Assistant Commissioner; and Julia Wickard, IDEM Agricultural Liaison.

IDEM stands ready to assist and address your questions and concerns.


