The 08/20 netDMR (001-C) for New Haven was due 09/28/2020, eight days ago. How long have you been in quarantine? How soon do you think you can submit?

I am forwarding this to Mr. Jason House who makes determinations on NPDES compliance during a COVID determination for NPDES reporting. Unfortunately, the EPA database has algorithms that consistently track and compare netDMR receipt date to expected due date, but Mr. House can let us know about IDEM compliance discretion for this situation.
