Pursuant to your email below, both Reo Water, Inc. and Midwestern Engineers, Inc. are in receipt of the permit. Also, as called for in the above referenced Permit for Public Water Supply Construction (Condition 1), this email is intended to notify you of commencement of construction for the following project:

1. Construction Permit Number: WS-12710
2. PWSID Number: 5274009
3. Location of Construction: The construction is located in various areas throughout the Reo Water service territory along SR 161, SR 66, Eureka Road, Orchard Road, and other County Roads near the unincorporated Communities of Reo, Patronville, Eureka and Richland City.
4. Description of Construction: The construction consists of installing approximately 197,000 L.F. of water main, replacements and improvements to the existing water treatment plant (including replacement of one aeralater unit, rehabilitation of a second aeralater unit, 2 new 300 gpm high service pumps, new chemical storage and feed equipment, a new restroom, additions to the backwash waste drain piping system, an addition to the existing backwash holding tank, and a simplex grinder wastewater pumping station and 2-inch force main), installation of a new 200,000 gallon multi-legged elevated water storage tank, demolition of an existing 50,000 gallon multi-legged elevated water storage tank, together with all the necessary appurtenances.
