On behalf of Kurt Veach, Water Utility Supervisor for Purdue University, we are writing to acknowledge receipt of the approved construction permit for improvements to the Purdue Animal Research Center public water system.

The project information that you require is provided below:

1. Permit #: WS-12700

3. Location of Construction: Approx. ½ mile east of U.S. 231 and 850' south of County Road 600N in Tippecanoe County.
4. Description of Construction: New public water supply well (16" steel casing, 225' depth, gravel packed, rated 1,000 gpm with vertical turbine line-shaft pump and associated chemical feed equipment, pumphouse, piping, valves, and metering equipment)
5. Construction Date Start: Earliest start date: April 1, 2024, pending availability of well contractor's personnel and drilling equipment.
