Dear Ms. Warren:

On June 25, 2024, we received the *SW ID 84-UP-09 and -10 Wabash River Station May Semi-annual sampling event* (email) from you. We offer the following comments.

The email documents that due to the weather the facility was unable to sample all the groundwater monitoring wells for both the North Ash Pond (NAP) and South Ash Pond (SAP) during the May 2024 sampling event. The facility was unable to sample the wells in the flood plain; therefore, the facility returned in early June 2024 and completed sampling by June 6, 2024. As a result, the facility does not have all the analytical data from the laboratory yet and will not be able to submit a complete groundwater monitoring report by early July. Therefore, the facility requests to submit a complete groundwater monitoring report for both the NAP and SAP by August 5, 2024.

We agree with the facility's proposed date of August 5, 2024, for the submittal of the complete groundwater monitoring reports for the NAP and SAP. Therefore, the facility needs to submit the complete groundwater monitoring reports for the NAP and SAP by end of day August 5, 2024.

Additionally, please address all future correspondence regarding groundwater monitoring (e.g., Corrective action, groundwater monitoring well install/abandonments, groundwater sampling, extension requests, etc.) to me and please carbon copy the permit manager, Lindsey Hummel on the correspondence. This will help to ensure a timely response.
