All,

I just received a call from Rob DeBeck, State Board of Health. He also received a complaint about this facility and went there yesterday. He said that he located a pipe down a horseman path that he thought was the discharge pipe from the WWTP into a small creek. Our permit says

it discharges into the reservoir and in the past, I was told that the discharge is sub-surface. He did dye test the effluent from the plant and waited about an hour with no visible signs of the dye tracing out of the pipe, but it was a Wednesday and very few people were at the campground. He also said that the water around this pipe indicated some pretty black discharge recently.

Myra, who is assigned this one and do you know if they have visited and/or dye tested?
