Good morning!

In response to the inspection for IN41319 on April 8, 2024, and the corresponding deficiencies, Marion Utilities is creating an action plan comprised to complete the following tasks and bring us back into compliance:

- Regularly pump down the pooling water from the "open" lagoon to the one in service and modify the berm to ensure no rain event would allow water to escape into the ditch.
- Create/modify/reinforce the berm surrounding the lime drying beds to capture and/or direct stormwater to the existing pump building located within the drying beds. This may be accomplished through a gravity drain or swales. (The pump station currently pumps waste from the claricones and filters to the lagoons.)
- The pump station will be evaluated to ensure the pumps are sufficient for pumping stormwater and runoff from the lime drying beds to the lagoon in service.
- The existing point of outfall from the lagoons to the ditch will be evaluated to determine a way to meter the flow and to see if additional treatment would be necessary before discharging.
- We will also actively participate in the permit modification process to accurate reflect our true outfall position.

Following an evaluation of our situation by appropriately qualified engineers, I will share our plan for approval and create a timeline for completing the project.
