Dear Sergio R. L. de Andrade:

A representative of the Indiana Department of Environmental Management (IDEM), Office of Air Quality (OAQ), has reviewed the 1<sup>st</sup> quarter 2024 quarterly report concerning Akzo Nobel Coatings, Inc. located at 1102 Leiter Drive in Warsaw, Indiana. Pursuant to Permit No. 47067, Condition C.17 General Reporting Requirements, the 1<sup>st</sup> quarter 2024 quarterly report was required to be submitted no later than April 30, 2024. The 1<sup>st</sup> quarter 2024 quarterly report was submitted on May 21, 2024, in violation of Permit No. 47067, Condition C.17 General Reporting Requirements.

This violation occurred in 2024 and should be included in the 2024 ACC, which is required to be submitted no later than July 1, 2025.

This violation is among those that IDEM has determined qualify for expedited enforcement. This means you will separately receive an expedited Notice of Violation (NOV) and a non-negotiable Agreed Order (AO) from an enforcement case manager. These documents will represent IDEM's best settlement offer in this matter to resolve the violation. The civil penalty included in the AO will be the penalty amount that IDEM will accept only for the settlement of the identified violations under its expedited enforcement program.
