Dear Mr. Reed:

A representative of the Indiana Department of Environmental Management (IDEM), Office of Air Quality (OAQ), has reviewed a stack test report concerning BP Products North America, Inc. – Whiting Business Unit (BP Products) located at 2815 Indianapolis Boulevard in Whiting, Indiana. As a result of information obtained during the review, IDEM alleges a violation of Title V 089-46607-00453, Condition D.2.2(g) has occurred.

At the time of the review, the following violations were noted:

- 1) Compliance testing conducted on March 14, 2024 indicates Condensable PM10 emissions from the New Coker (#2 Coker) Heater F-201 was measured at 0.01366 lbs/MMBtu, exceeding the permitted limit of 0.0081 lbs/MMBtu.
- 2) Compliance testing conducted on March 12, 2024 indicates Condensable PM10 emissions from the New Coker (#2 Coker) Heater F-202 was measured at 0.01169 lbs/MMBtu, exceeding the permitted limit of 0.0081 lbs/MMBtu.

This matter will be referred for formal enforcement action. IDEM OAQ would like to take this opportunity to encourage discussions concerning the facts of the case, any additional information that may be available, and to provide you with information concerning the enforcement process prior to issuance of a formal Notice of Violation and Proposed Agreed Order.
