Dear Justin Sanchez:

A representative of the Indiana Department of Environmental Management (IDEM), Office of Air Quality (OAQ), has reviewed the 1<sup>st</sup> quarter 2023 and 2024 quarterly reports concerning Dexter Axle Company located at 500 South 7<sup>th</sup> Street in Albion, Indiana. Pursuant to Permit No. 46014, Condition C.16 General Reporting Requirements, the 1<sup>st</sup> quarter 2023 and the 1<sup>st</sup> quarter 2024 quarterly reports were required to be submitted no later than April 30, 2023, and April 30, 2024, respectively. The 1<sup>st</sup> quarter 2023 quarterly report was submitted on May 19, 2023, and the 1<sup>st</sup> quarter 2024 quarterly report was submitted on June 4, 2024, in violation of Permit No. 46014, Condition C.16 General Reporting Requirements.

The violation for the late submittal of the 1<sup>st</sup> quarter 2023 report occurred in 2023 and should be included in the 2023 ACC, which is required to be submitted no later than July 1, 2024. The violation for the late submittal of the 1<sup>st</sup> quarter 2024 report occurred in 2024 and should be included in the 2024 ACC, which is required to be submitted no later than July 1, 2025.

These violations are among those that IDEM has determined qualify for expedited enforcement. This means you will separately receive an expedited Notice of Violation (NOV) and a non-negotiable Agreed Order (AO) from an enforcement case manager. These documents will represent IDEM's best settlement offer in this matter to resolve the violation. The civil penalty included in the AO will be the penalty amount that IDEM will accept only for the settlement of the identified violations under its expedited enforcement program.
