GENERAL INFORMATION

Comments:

On February 4, 2024, the Indiana Department of Environmental Management received a complaint indicating trash on Crawford County property parcel 13-10-11-102-001.000-012 is spilling onto the neighboring property. The complaint also indicates trash on Crawford County property parcel 13-10-11-102-001.000-012 can be observed throughout the property from satellite imagery.

On February 6, 2024, Solid Waste Compliance Inspector Chad Pittman, conducted the initial open dump complaint inspection on Crawford County property parcel 13-10-11-102-001.000-012 located at 3802 South Colvert Roll Road, English, Indiana 47118 with a subsequent inspection report and violation letter for open dumping violations being issued.

On June 27, 2024, Solid Waste Compliance Inspector Chad Pittman, conducted an open dump complaint follow-up inspection on Crawford County property parcel 13-10-11-102-001.000-012 located at 3802 South Colvert Roll Road, English, Indiana 47118.

The open dump complaint follow-up inspection was conducted pursuant to IC 13-14-2-2. In accordance with IC 13-14-5, a summary of the open dump complaint follow-up inspection is provided below.

The solid waste compliance inspector arrived at 3802 South Colvert Roll Road, English, Indiana at 9:45 AM on Thursday, June 27, 2024. The inspector met on site with Ms. Lisa Sheckells, who is residing on the property. The inspector requested and was granted permission to conduct a follow-up inspection on the property.

The solid waste compliance inspector observed evidence that illegal disposal of solid waste is occurring or has occurred on Crawford County property parcel 13-10-11-102-001.000-012.

Multiple types of regulated solid waste including household waste, construction/demolition debris, waste tires, and miscellaneous bulky waste were observed remaining on Crawford County property parcel 13-10-11-102-001.000-012 at the time of the follow-up inspection. No notable progress toward compliance has been made since the initial open dump complaint inspection conducted on February 6, 2024. Photographs of the remaining regulated solid waste on the property are included as an attachment to this inspection report.

DESCRIPTION OF VIOLATIONS

IC 13-30-2-1 (1), (3), (4), (5): A person may not allow the deposit of contaminants or solid waste upon the land or into the environment.

329 IAC 10-4-2: No person shall cause or allow the storage, contaminant, processing, or disposal of solid waste in a manner which creates a threat to human health or the environment, including the creating of a fire hazard, vector, attraction, air or water pollution, or other contamination.

329 IAC 10-4-3, 329 IAC 10-4-4: Open dumps are prohibited and must be remediated.

Violation Details: At the time of the follow-up inspection, the solid waste compliance inspector observed household waste, construction/demolition debris, waste tires, and miscellaneous bulky waste dumped on the ground throughout the property (See Photographs 1-6).

Required Action: It is the responsibility of the property owner to ensure that all dumping is stopped immediately and the regulated solid waste on Crawford County property parcel 13-10-11-102-001.000-012 is removed and disposed of properly at a state approved solid waste management facility. Failure to do so will result in continued noncompliance with the Indiana rules regarding open dumping and may result in a referral to IDEM's Office of Land Quality Enforcement Section. Documentation of proper disposal must be provided to the IDEM Solid Waste Compliance Inspector.

Please note that Indiana's Air Pollution Control Rule 326 IAC 4-1 prohibits the open burning of this waste. Section 5 of this rule states, "Any person who allows the accumulation or existence of combustible material which constitutes or contributes to a fire causing air pollution shall not be excused from the responsibility thereof on the basis that the fire was set by vandals, accidental or an act of God." Any burning of this waste may subject you to legal action.

Within 30 days of receipt of this letter, another follow-up inspection will be conducted to verify compliance with the requirements listed above. If additional time is requested to conduct the clean-up activity, a detailed compliance schedule must be presented to the solid waste compliance inspector for review and approval.

Confidential Information

In accordance with 329 IAC 6.1 (http://www.in.gov/legislative/iac/T03290/A00061.PDF) a person submitting information to the department for which confidential treatment is requested shall make a written claim of confidentiality at the time of submittal of the information. A person may request confidential treatment of information at the time the information is acquired through the actions of the department, such as inspections. The written claim for confidential treatment may be broad, but must be sufficiently clear to allow for accurate identification of the information claimed to be confidential. In accordance with 329 IAC 6.1-4-1(d), supporting information must be submitted to the commissioner within five (5) working days from the time the information claimed as confidential is acquired by the department. A person submitting a claim of confidentiality shall designate and segregate the information and the supporting information to which the claim applies in a manner that is sufficiently clear to allow the department to identify all confidential claim materials. Confidential information may include (but is not limited to) written or printed material, maps, charts, photographs, or samples (see definition of information at 329 IAC 6.1-2-8). The undersigned Owner/Representative has alleged information acquired during this inspection does does not (check one) contain confidential information. A check in the "does" box is not a written claim for confidential treatment of information acquired during this inspection.

Notice of Oral Report

In accordance with IC 13-14-5 an oral report of the inspection was provided to the undersigned Owner/Agent at the conclusion of the inspection. The oral report includes any specific matters discovered during the inspection that the IDEM representative believes may be a violation of a law or of a permit issued by the department. The report does not include matters not evident to the IDEM representative or any fact that indicates an intentional, a knowing, or a reckless violation.
