IDEM received a request for waiver of the Initial Site Characterization (ISC) requirements, submitted on your behalf by James Hoover of Aegis Environmental on June 17, 2024, for the Hanenkratt Grain facility located at 471 South 300 East in Monticello, Indiana.

The request to submit an Underground Storage Tank (UST) Closure Report in lieu of an ISC Report has been approved. This alternative procedure must provide substantially equal protection to human health and the environment, and the completed report must be submitted on or before July 27, 2024. Upon review of the UST Closure report, a determination will be made for additional investigation or for incident closure.

Approval of this waiver is based on the information provided to IDEM per Indiana Code 13-23-13-1. You may be required to submit additional information to fulfill requirements related to the UST closure by Petroleum Remedation Section (PRS) staff. Any additional requests regarding your UST Closure Report will be sent to you by the PRS. Failure to submit your UST Closure report within the specified timeframe may result in a referral to IDEM Enforcement. In addition, as long as you are not in compliance with these requirements, you are not eligible for reimbursement for claims from the Excess Liability Trust Fund (ELTF). If you anticipate seeking reimbursement for your remediation costs, please contact the ELTF Section at (317) 234-0990.
