- 1. By January 31 of each year, a scrap tire hauler shall annually register with the Department on a form provided by, and containing the information required by, the Department. A scrap tire hauler who does not provide all of the information required by the Department shall not be considered registered under this part.
- 2. Issuance of this Registration is based on the completeness and accuracy of the information submitted in the Application and any amendments to the Application. Any inaccuracy or deviation found in that information is grounds for the revocation or modification of this Registration and maybe grounds for enforcement action. The Registrant shall inform the EGLE-ScrapTire@Michigan.gov of any known inaccuracy or any deviation in the information in the Application and amendments thereto that would affect the Registrant's ability to comply with Part 169.
- 3. All loads of scrap tires transported by a scrap tire hauler in the state of Michigan must be accompanied by a completed Scrap Tire Transportation Record. The Department prepared Scrap Tire Transportation Record (Form Number EQP 5128) and the Consolidated Load

- Scrap Transportation Record (Form Number EQP 5128a), are the only forms approved for use. These forms can be obtained from the Department web site at: http://www.michigan.gov/scraptires or by contacting the Department.
- 4. A scrap tire hauler, when transporting scrap tires, shall have in his or her possession a copy of the current unexpired scrap tire hauler registration and shall present it upon demand of a peace officer. The scrap tire hauler registration number issued by the Department shall be visibly displayed on a vehicle transporting scrap tires.
- 5. This Registrant shall otherwise act under this Registration in accordance with Part 169 and all other applicable federal or state laws.

- 2. The current scrap tire hauler registration number, issued by EGLE, must be visibly displayed on a vehicle transporting scrap tires.
- 3. A scrap tire hauler must maintain a record of each load or consolidated load of scrap tires transported. Only EGLE Form EQP 5128, the Scrap Tire Transportation Record, and EQP 5128a, the Consolidated Load Scrap Tire Transportation Record, may be used by a scrap tire hauler. No other scrap tire transportation record form will be approved. You must use the EGLE form. These forms may be copied for use by the hauler. This form can be obtained from the EGLE Web site at http://www.michigan.gov/egle or by contacting EGLE.
- 4. A copy of the Scrap Tire Transportation Record shall be provided to the person/business listed in Part 1 of the form at the time of removal of the tires.
- 5. The original Scrap Tire Transportation Record shall be in the possession of the scrap tire hauler during the actual transportation of the scrap tires. The scrap tire hauler shall maintain this record for 3 years and shall be made available, upon request, to the EGLE or to a peace officer at reasonable hours.
- 6. A copy of the Scrap Tire Transportation Record shall be provided to the person/business listed in Part 3 of the form at the time of delivery. Scrap tire haulers shall not dispose of scrap tires at a site other than the site identified in Part 3 of the Scrap Tire Transportation Record.

Financial assurance must be in the form of: (A) a bond for performance, executed by a corporate surety licensed to do business in Indiana; (B) a negotiable certificate of deposit; or (C) a negotiable letter of credit; payable to the department and conditional upon faithful performance of the statute and registration. Financial assurance must be in effect and the application approved before accepting tires or tire products for transportation.

As I mentioned on our call, we received the attached financial assurance reinstatement. \$10,000 is the required amount for waste tire transporters, however, a record review shows the last registration on file for Larry's Tire expired in 2006 (Virtual File Cabinet Document 63783172). If you think this is a mistake or another name is being used for your company, please let me know. Waste tire transporters are required to submit a renewal application every 5 years.

### Required Items:

- Fee Transmittal State Form 47215 (attached) \$25 new application fee, send the payment to the PO Box or as directed on the form, include a copy with the rest of the application. **Do not** send the full application to the PO Box.
- Application Form 47220 (attached) and supporting documents
  - Email the completed application and <u>copy</u> of the payment as a PDF to <u>SolidWasteSubmittals@idem.in.gov</u>. You can copy me. There is no need for a hard copy of the full application if you email it.
  - Section 3, Full name: Should be the company's name. All businesses doing business in Indiana should be registered with the Indiana Secretary of State.
