Dear Mr. Caldwell,

I am providing documentation of the final cleanup for the oil spill incident that occurred at 1430 N. National Road in Columbus, IN. Due to a severe storm in the area on March 14th, 2024, power lines and two poles were torn down by strong winds and the attached transformers were knocked to the ground releasing an estimated total of 80 gallons of oil. All damaged transformers were identified as non-PCB per manufacturer nameplates.

First responders took preventative measures to contain the spill, and no storm sewers were impacted. JDH Contracting was dispatched to clean up contaminated soil and treat an asphalt parking lot with loose absorbents. All excavated soil and resulting debris were hauled to an approved landfill using the attached manifest. JDH also restored the maintained grass areas.
