Emmeline and Dwight,

Based on the findings noted in August Mack's memo and their recommendations, we collected an additional sample for surfactants within the stormwater pond to confirm that surfactant concentrations are well below the 1.0 mg/L noted in the memo. The sample was collected on April 26th and resulted in nondetectable concentrations of surfactants within the pond. This is in good agreement with the expectations expressed in August Mack's memo, and supports the one-time off-site spill hypothesis. Therefore, we do not expect discharge from the stormwater pond poses any risk to aquatic life. We would appreciate for our records when you decide to close your case, some notification that the case is closed.
