

This letter is in response to the compliance evaluation inspection that was conducted at our facility, 505 Industrial Drive, on 6/3/2024 and subsequent violation(s) that were observed. At the time of the inspection it was noted that our "Quick Reference Guide" did not contain all of the required information. The following items were missing and have been corrected in Martinrea's QRG:

- (4) A map of the facility showing where hazardous wastes are generated, accumulated and treated and routes for accessing these wastes;*
- (5) A street map of the facility in relation to surrounding businesses, schools and residential areas to understand how best to get to the facility and also evacuate citizens and workers;*
- (6) The locations of water supply (e.g., fire hydrant and its flow rate);*
- (7) The identification of on-site notification systems (e.g., a fire alarm that rings off site, smoke alarms)*

A copy of the Quick Reference Guide (QRG) is attached to this letter and copies of the revised guide and Contingency Plan will be sent to the local emergency response agencies. Please let us know if you have any questions or concerns.

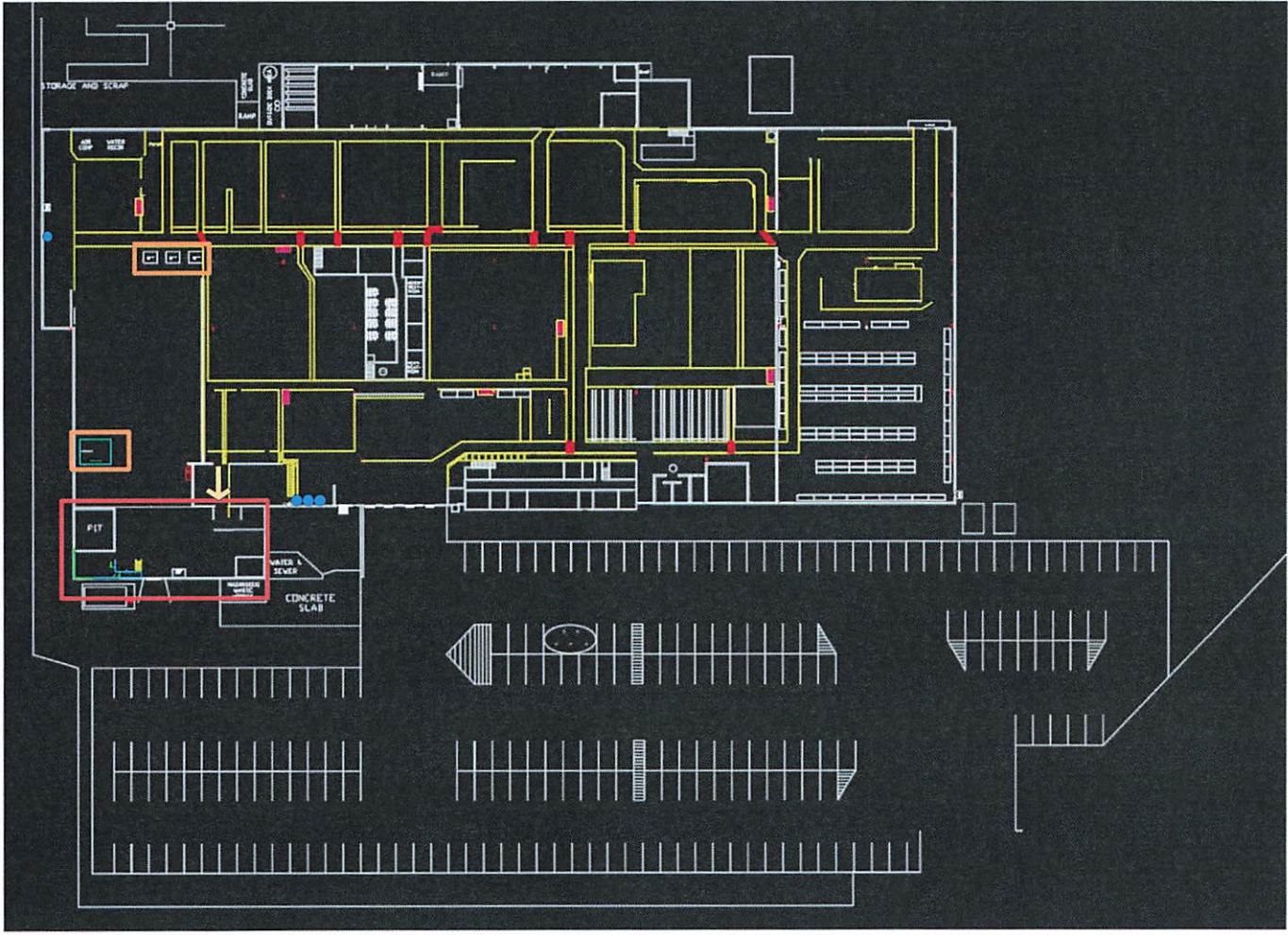
