On July 1, 2024 you submitted an email requesting a 30-day extension for hazardous waste that will exceed the 90 days allowed for large quantity generators. The waste in question consists of four (4) waste streams from tank cleanouts at the facility in 74 containers ranging from 5000-gallon frac tanks to 55-gallon containers. The accumulation start date for the waste ranges from April 3, 2024, through April 25, 2024. The reason for the extension request is due to your logistical issues with the vendor/hauler and awaiting vendor to approve profile.

Pursuant to 40 CFR 262.17(b) as referenced by 329 IAC 3.1, an extension is granted for this waste due to your extenuating circumstances. Be advised that no further extensions can be granted under Indiana Rules.
