On 7/1/2024, a representative of the Indiana Department of Environmental Management, Office of Land Quality, conducted a record review of Red Spot Paint and Varnish Company, located at 1016 E Columbia Street, Evansville, Indiana. Summary of Other Record Review

On April 23, 2024, IDEM inspected Accelerated Curing located at 304 East County Road 100 North in Portland Indiana. During this inspection it was noted that in Line 1 they solely use a Red Spot UV topcoat. Overspray from this line is captured in filters, then collected in a basin and pumped into a 55-gallon drum; these drums are then sent to Red Spot Paint and Varnish Company on a Bill of Lading for reclamation. According to facility representatives, Red Spot filters the waste coating and adds solvent to make a product that can be resold.

Upon further review, it appears the waste coating from Line 1 meets the definition of a "spent material" in 40 CFR §261.1(c)(1): a spent material is "any material that has been used and as a result of contamination can no longer serve the purpose for which it was produced without processing." Due to the need for Red Spot to filter the topcoat and add additional solvent to make a re-sellable product, the used topcoat produced from Accelerated Curing's Line 1 meets the definition of a spent material, and thus would be a characteristic hazardous waste.

Information provided by the generator indicates that Red Spot considers the used coating to be a product, but additional information is necessary to determine the regulatory status of the used coating, the generator, and the receiving facility/reclaimer.

Description of Violation(s)

329 IAC 3.1-6-2(2): Respondents in actions to enforce regulations implementing IC 13 who rasie a claim that a certain material is not a solid waste, or is conditionally exempt from regulation,

must demonstrate that there is a known market or disposition for the material and that they meet the terms of the exclusion or exemption. In doing so, they must provide appropriate documentation to demonstrate that the material is not a waste or is exempt from regulation. In addition, owners or operators of facilities claiming that they actually are recycling materials must show that they have the necessary equipment to do so.

Results/Actions

Within fifteen (15) days of receipt of this report, provide documentation to IDEM that details which exclusion or exemption is being claimed for the used coating, and demonstrate how Red Spot meets the conditions for that exclusion or exemption.

Failure to properly support this claim may result in additional violations being cited and appropriate enforcement action.
